The Management Board of ELZAB S.A. Computer Works in Zabrze informs that today the Supervisory Board, acting in virtue of clause 13 par. 4 of the Company Statute appointed Mr. Eugeniusz Pajaczek the Chairman of the Management Board with effect from 1<sup>st</sup> April, 2009.

3) he is not listed in the Register of Insolvent Debtors kept in virtue of the Law on National Court Register [KRS].
